
Major County Sheriffs of America and guests,





PANDA ADKINS DIRECTOR JAILS AND JUSTICE SUPPORT CENTER Panda Adkins serves as the Director of the Jails and Justice Support Center (JJSC) in the Center for Justice Research and Innovation at CNA. In 2022, the Bureau of Justice Assistance (BJA) and the National Institution of Corrections (NIC) selected CNA to lead the development and delivery of the JJSC.
