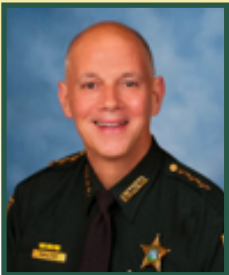


**Vice President Elect**  
Sheriff Mark Napier  
Pima County, AZ

Sheriff Mark Napier was elected as the 34th Sheriff of Pima County on January 1, 2017. He started his law enforcement career in December of 1981 as a police officer in Iowa. He was hired by the Tucson Police Department in 1987, eventually retiring as a captain. He then served as the Assistant Director for the Glendale Arizona Police Department and worked for the Department of Justice as a peer reviewer on federal grant programs.

Sheriff Napier is a decorated law enforcement leader. He has received the Medal of Merit twice, the Medal of Service, the Chief of Police Citation of Excellence, the Unit Medal, the Retirement Medal and the Magnus Leadership Medal. He serves as a member of the Executive Committees of the Arizona Joint Terrorism Task Force, Arizona High Intensity Drug Trafficking Area, the Arizona Criminal Justice Commission and Major County Sheriffs of America and is also a member of Unified Command of the Alliance to Combat Transnational Threats. He is currently the elected Vice President of the Arizona Sheriffs Association.

Sheriff Napier holds a Bachelor of Science Degree in Social Psychology from Park University and a Masters Degree from Boston University in Criminal Justice. For the past 14 years, he has taught for the online Masters of Criminal Justice Program at Boston University. He has been married to wife Marlene for 35 years and has four adult children, one of whom is a Tucson Police Officer.



**Treasurer Elect**  
Sheriff Bob Gualtieri  
Pinellas County, FL

Bob Gualtieri began his law enforcement and public service career over 35 years ago as a detention deputy working in the Pinellas County, FL jail. After attending the police academy, he joined the Dunedin Police Department as a patrol officer and later rejoined the Pinellas County Sheriff's Office as a law enforcement deputy. His service in the agency included several years conducting domestic and international drug trafficking investigations as part of a DEA task force. Sheriff Gualtieri earned his bachelor's degree from Eckerd College in St. Petersburg and his law degree from Stetson University College of Law. After graduating from Stetson and being admitted to the Florida Bar, Bob entered private practice in Tampa, specializing in labor and employment defense.

Returning to the Pinellas County Sheriff's Office in 2006 as its general counsel, he was appointed chief deputy in 2008. Sheriff Gualtieri served in the dual role of general counsel and chief deputy until his appointment to the office of sheriff in 2011. He was elected in 2012 and reelected in 2016. Sheriff Gualtieri serves on the board of directors for the Florida Sheriffs Association (FSA) and as Treasurer of MCSA. He is the chair of the FSA Legislative Committee and the MCSA Legal Affairs Committee. He is also an Executive Fellow for the Police Foundation, member of the National Sheriff's Association, International Association of Chiefs of Police, and the Police Executive Research Forum.

Loudoun County, VA

Mike Chapman was elected Sheriff, Loudoun County, VA in 2011 and took office January 2012. Sheriff Chapman formerly worked for the Howard County Maryland Police Department in the Divisions of Patrol, SWAT and Criminal Investigations; and for the DEA as the Assistant Special Agent in Charge, Northern District of California; as Acting Regional Director of the Far East; as DEA's Chief of Public Affairs; as the Country Attaché for Seoul, Korea; as a Supervisor in McAllen, Texas; and in field assignments in Miami, Tampa, and Pakistan. In the private sector, Sheriff Chapman worked as a Subject Matter Expert on the Global Security/Law Enforcement team with Booz Allen and Hamilton.

Sheriff Chapman has a Bachelor of Science in Business Management, University of Maryland (Honors), and a Master's in Public Administration from Troy State University, Alabama. He previously served on the Governor's School and Campus Safety Task Force, the National Sheriffs' Association, Major County Sheriffs' Association, and the Virginia Sheriffs' Association's Congressional and Legislative Committees. He graduated from the FBI National Executive Institute (NEI) and Law Enforcement Executive Development Association (LEEDA); the US Army War College – National Security and Strategy Seminar (Certificate of Leadership Development); the National Sheriffs' Institute, the Virginia Sheriffs' Institute, and earned the Virginia Department of Criminal Justice Services' Executive certification.
